
Sept. 5 Labor Day This is a national holiday honoring the work force in the United States. **Government offices and** many businesses are closed for this holiday.

In the past year, we have dealt with two ice storms and a large wildfire that destroyed hundreds of poles across our system. Once again our employees restored service and rebuilt electric circuits to strengthen our system and enhance our ability to respond to outages caused by major storms.

We have also experienced the largest growth in sales ever in our history due

AEC sends students to Colorado

Nick Nakvinda, from Ringwood and McKayla Holson from Waynoka were selected to attend the 40th annual Cooperative Youth Leadership Camp in Steamboat Springs, Colo. From July 16-22, Nick and McKayla joined approximately 100 youth from Kansas, Colorado, Wyoming and Oklahoma for the week-long camp that combines education about the cooperative business model with traditional camp pastimes.

McKayla and Nick were selected through AEC's Youth Tour Program. Information on the program was shared with students and teachers within AEC's seven county service area (5 in Oklahoma and 2 in Kansas). Six students were selected from their winning essays. Those students then went through a short interview where judges selected the winners.

Alfalfa Electric Cooperative is proud to be a participating sponsor of the Cooperative Youth Leadership Camp and send our local youth to develop essential leadership and teamwork skills. Through this trip, AEC hopes local students will learn how our electric cooperatives work and how co-ops and their employees support the communities they serve.

committees and elected a general
manager and board of directors.
Campers also had time to enjoy area
activities including visits to Fish Creek
Falls and Steamboat Springs, river
rafting and participating in camp

The youth learned about the workings of electric cooperatives through a variety of activities: Yampa Valley Electric's linemen led a high voltage safety demonstration, campers competed in building a model transmission line out of craft

2015 TAX ALLOCATION NOTICE

The Notice of Patronage Taxable Income Allocation for Tax Purposes is issued in accordance with the Bylaws of Alfalfa Electric Cooperative, Inc. The amount of patronage taxable income for the calendar year 2015 that exceeds patronage book income due to 2015 net temporary book/tax differences is \$11,414,362. The allocation factor is .2573501390.

To determine the amount of your allocation, multiply the allocation factor by the total dollar amount charged for KWH usage on your electric bill in 2015. This allocated amount is not immediately available as either cash or credit on your

electric bill.

These notices are redeemable only at the discretion of AEC's Board of Directors, and are not required to be reported by you for income tax purposes until redeemed for cash and then only if you receive an income tax deduction for the payment made to the cooperative during 2015. Accordingly, it is unlikely that residential patrons will be required to report such allocations even when paid to them in cash or credited to their electric bill.
